- 2. All such educational institution shall have to first register themselves in the AHSEC web portal giving details of data as required by the portal.
- 3. All students shall have to register themselves in the AHSEC web portal using their Roll Number and choose maximum five institutions in order of their performance for admission.
- 4. The Educational institution shall be able to choose students from the portal and on getting approval by the institution, the students shall be able to lock his choice and take the admission.
- 5. All educational institutions admitting students in class XI shall have to provide admission in class XI, only through the portal of AHSEC and not by any offline process.
